I understand that once USC University Hospital discloses my health information to the recipient, USC University Hospital cannot guarantee that the recipient will not redisclose my health information to a third party. I understand that USC University Hospital may, directly or indirectly, receive remuneration from a third party in connection with the use or disclosure of my health information.

I understand that I may at any time make a written request to USC University Hospital to inspect and/or obtain a copy of my health information, and that USC University Hospital will either, within five days for a request to inspect and fifteen days for a request to copy, grant the request and contact me to arrange for a convenient time to inspect and/or copy my health information or provide me with a written denial of the request that states the basis for the denial, my review rights (if any), and instructions as to how and to whom I may register a complaint regarding the denial.

I understand that I may refuse to sign or may revoke (at any time) this Authorization for any reason and that such refusal or revocation will not affect the commencement, continuation or quality of my treatment at USC University Hospital; except, however, if my treatment at USC University Hospital is for the sole purpose of creating health information for disclosure to the recipient identified in this Authorization, in which case USC University Hospital may refuse to treat me if I do not sign this Authorization.

I understand that, at any time during which this Authorization is in effect, I may make a written request to receive a copy of this Authorization. Such written request shall be made to USC University Hospital's Privacy Office at the address listed below.

I understand that this Authorization will remain in effect until the term of this Authorization expires or I provide a written notice of revocation to **USC University Hospital**'s Privacy Office at the address listed below. The revocation will be effective immediately upon USC University Hospital's receipt of my written notice, except that the revocation will not have any effect on any

action taken by USC University Hospital in reliance on this Authorization before it received my written notice of revocation.
